Purchasing Lands Adjacent Robertson Ave, Springhill NS, PID#25228214, No assigned AAN# at this time. The property is located with frontage directly at end of Robertson Ave. This property is not migrated into the Land Registry system. The potential Purchaser will be responsible for legals costs for migration, the preparation of an agreement of purchase and sale and any other related closing costs. The lands have access to central water and sewer however, extension of these services will be at the cost of the successful bidder. The property is being offered for tender as is where is.

Council is seeking market value-based bids on this property, in addition to the criteria laid out below.

Issuing an Invitation implies no obligation on the Municipality of the County of Cumberland to accept any submission, or a portion of any submission. The lowest of any submission will not necessarily be accepted.

Submissions will be scored based on the criteria/scoring noted below in the required information sections. A staff committee will review and score the submissions.

The Municipality may include a buyback provision in the Purchase and Sale Agreement with the successful bidder that would align with proposed timing for development of the lands.
