

SCHEDULE A

ALL that certain lot of parcel of land situate and lying in Port Howe, in the County of Cumberland and Province of Nova Scotia, bounded and described as follows:

BEGINNING at Hance Field's northwest corner and running along said Hance Field's west line until it comes to land of the late Jeptha Field;

THENCE along the line of land owned by the said Jeptha Field until it strikes the new road;

THENCE in a north easterly direction along said new road until it strikes the shore road and crossing said shore road and continuing in the same direction along lands of John McDonald until it strikes land of John F. Dunbar;

THENCE in a south easterly course along lads of said John F. Dunbar until it strikes the shore road aforesaid, containing 30 acres, more or less, and being the property known as the Thomas Glynn property which was deeded to the said Jeptha Field by Johnson Hollis by deed dated November 2, 1918 ad recorded at the Registry of Deeds at Amherst, N.S. in Book 138 at Page 191.
