

ALL that lot of land situate at West Pugwash, in the County of Cumberland, and Province of Nova Scotia, more particularly bounded and described as follows:-

BEGINNING at a set iron bar at the intersection of the Westerly margin of the Sunrise Trail, so-called, being Provincial Highway # 6, with the Northerly margin of the Murray Road, so-called;

THENCE North Thirty-three Degrees Thirty-four Minutes West (N33°34'W) along the Sunrise Trail a distance of Fifty point Forty-five Feet (50.45') to a found iron pin;

THENCE South Seventy-two Degrees Twenty-six Minutes West (S72°26'W) a distance of Two Hundred and Ninety-seven point Fifteen Feet (297.15') to a set iron bar;

THENCE South Twenty-three Degrees Fifteen Minutes East (S23°15'E) a distance of Thirty-three point Seventy-one Feet (33.71') to a set iron bar on the Northerly margin of the aforesaid Murray Road;

THENCE along the Northerly margin of the said Murray Road a distance of Three Hundred and Ten Feet (310'), more or less, in an arc having a tie line running South Seventy-five Degrees Twelve point Seven Minutes East (S75°12.7'E) a distance of Three Hundred and Eight point Zero Six Feet (308.06') to the place of beginning.

CONTAINING Fifteen Thousand Five Hundred (15,500) Square Feet, more or less.

BEING those lands conveyed by the heirs-at-law of Greta White to Margaret Ferdinand by Deed dated the 5th day of November, A.D., 1973 and recorded at the Registry of Deeds Office, Amherst, N.S., in Book 311 at Page 519 and as shown on a Plan entitled "Plan Showing Lands of James Ferdinand" drawn by Daniel B. Burke dated the 19th day of October, A.D., 1977 and filed at the Registry aforesaid as P-No. 1137.

AND ALSO BEING the same lands as conveyed by Sheriff's Deed dated the 26th day of November, 1984 to Canada Mortgage and Housing Corporation and recorded at the Registry of Deeds aforesaid in Book 462, at Page 86.

AND ALSO BEING the same lands as conveyed by Quit Claim Deed from Ella Ferdinand, Verna Bergman, Cora Reid, Ronald White, Arnold White, Myra Bonnyman, Jackeline White and Robert White dated April 3rd, 1986 to Canada Mortgage and Housing Corporation and recorded at the Registry of Deeds aforesaid in Book 498, at Page 875.

AND ALSO BEING AND INTENDED TO BE the same lands as conveyed from Aubrey M. Chapman to Canada Mortgage and Housing Corporation by sheriff's deed dated the 3rd day of January, 1989 and recorded in the Registry of Deeds at Amherst in the County of Cumberland, N.S., on January 3rd, 1989 in Book Number 527 at Pages 36 - 37.
