



## SCHEDULE "A"

ALL that lot of land situate at Maccan aforesaid on the southerly side of the main road leading from Maccan to Athol, bounded and described as follows:

BEGINNING at a stake driven at the northeast corner of a lot of land formerly owned by William Higgins;

THENCE southerly along the eastern line of the said Higgins lot about Ninety-Three feet (93') or to the southeasterly corner of the said Higgins lot;

THENCE easterly the same course as the south line of the Higgins lot a distance of Forty feet (401) to a stake;

THENCE North Fifty-Nine degrees East (N59°E) a distance of One Hundred Eight feet (1081) or until the southerly boundary of the said main road is reached;

THENCE westerly along the said Southerly boundary of the road a distance of One Hundred Five feet (105') to the place of beginning, and containing one-seventh (1/7) of an acre, more or less.

BEING that land conveyed to Gary D. Hurley by Jean Porbes Loring by Deed dated the 17th day of November, A. D., 1969 and recorded at the Registry of Deeds Office for the County of Cumberland at Amherst, N. S. on November 28, 1969 in Book 263, at Page 794 as number 2461-1969.
