

### Lot I.

ALL that certain lot, piece or parcel of land situate in New Prospect, in the County of Cumberland and Province of Nova Scotia, bounded as follows:

BEGINNING at a spruce tree standing at the northwest angle of land granted to Peter McLellan;

THENCE running S4°W, along the western line of the said McLellan land 71 chains and 43 links to a maple tree;

THENCE N86°W, 14 chains to a fir tree;

THENCE N4°E, 71 chains and 43 links to a spruce tree;

THENCE S86°E, 14 chains to place of beginning.

BEING 100 acres more or less.

EXCEPTING AND RESERVING a certain piece out of the same, lying north of Five Island Road, lying between the east line of the said lot and the brook from the falls on said brook at the north side of said brook, till it comes to a fir tree standing on the north side of said brook;

AND FROM THENCE on a straight line to the road;

THENCE following easterly along said Road, to place of beginning.

CONTAINING 2 acres more or less.

ALL that certain lot, piece or parcel of land situate, lying and being at New Prospect, aforesaid and bounded and described as follows:

PROPERTY at Prospect between Varley Fullerton on the east and W.W. Hatfield on the west;

THE main road from Parrsboro to Five Islands on the south; and

THE Nashwaak Paper Co. on the north.

FORMERLY described in Deed from Nelson Phinney and wife to B. L. Tucker, Book 24, Pages 386 and 387, April 19th, 1905, as follows:

ON the north by the base line of Two Island Settlement lots;

ON the south by the Main Post Road, leading from Parrsboro to Five Islands;

ON the cast by the west line of the George Miller lot, so called;

AND ON the west by the east line of lands formerly owned by one W. H. Jones and formerly known as the west half of the Wasson lot.

THE said lot having been deeded to one J. M. Blaikie by Mary Jane Wasson of Two Islands, December 1<sup>st</sup>, 1885. Deed by B. L. Tucker to J. W. Kirkpatrick et al in 1926, Page 84, Book 33, in conveyance of the Moose River Property to J. W. Kirkpatrick. This was not included in the conveyance from Moose River Lumber Co. to Lincoln Pulpwood Co.

SAVING AND EXCEPTING out of the lands conveyed by Annie May Wood to Budd Lunn aforesaid, the following two lots:

### FIRSTLY:

ALL that certain lot, piece or parcel of land conveyed by Budd Lunn and Marion Lunn to Lavenia Edith MacAleese by Deed dated the 12<sup>th</sup> day of October, A.D., 1962, and recorded at the Office of the Registry of Deeds, at Amherst, in Book 237 at Page 579, said lands being more particularly

ALL that certain lot, piece or parcel of land lying, situate and being at New Prospect, aforesaid, and bounded and described as follows:

BEGINNING at a point on the northerly verge of the main highway running from Parrsboro to Truro, at the southeasterly corner of land formerly owned or occupied by Daniel MacAleese;

THENCE running in a northerly direction along the said MacAleese easterly line, a distance of 230 feet;

THENCE at right angles in an easterly direction to a small maple tree and a distance of 104 feet;

THENCE at right angles in a southerly direction to the north verge of the said highway, a distance of 230 feet;

THENCE running in a westerly direction along the northerly verge of the said highway, a distance of 104 feet to the place of beginning.

BEING a portion of the second lot described in the Deeds from Annie May Wood to Budd Lunn.

### SECONDLY:

BEGINNING at a red stake No. 1963, so placed by Minas Basin Pulp and Paper Company on the south side and adjacent to the main road from Parrsboro to Five Islands and on the west line of lands now or formerly in the possession of Scott Paper Company;

THENCE along the west line of the said Scott Paper Company lands in a southerly direction to the Brook marking the north line of lands now or formerly belonging to Mrs. Harold MacGillivory;

THENCE in a westerly direction along the north boundary of the said MacGillivory to a point marking the northwest corner of the MacGillivory lands;

BEGINNING at a red stake No. 138, 1963, so placed by Minas Basin Pulp and Paper Company at the base of the hill on the north side of the main highway between Parrsboro and Five Islands, and on the west side of lands now or formerly in the possession of Scott Paper Company;

THENCE northerly along the west line of the Scott Paper lands, until it meets the east branch of the Wasson Brook, so called;

THENCE westerly at right angles to the Scott Paper west line to the eastern edge of the west branch of the Wasson Brook;

AND BEING included in the lands as conveyed by Deed dated July 27, 1999, from Janis Cunningston Blair to Dennis Babineau and Donna Babineau, spouses, as joint-tenants, and recorded at the Registry of Deeds Office at Amherst, Nova Scotia, in Book 706 at Page 801.

TOGETHER WITH a right-of-way from Highway 2 (over lands of the grantors Dennis Babineau and Donna Babineau, being P.I.D. #'s 25083163 and 25181140), to the above lands for the usual passage of pedestrian and vehicular traffic, ingress and egress, over the existing road.
