

# PID 25233537 LOT 1

ALL that lot of land situate in the Town of Springhill, in the County of Cumberland, bounded and described as follows:

**BEGINNING** at the North East angle of Main and Elm Streets:

THENCE running Southerly along the West side line of said Elm Street, sixty-one feet and eight inches;

THENCE Westerly and parallel with Main Street twenty-seven feet;

THENCE Northerly parallel with the said Elm Street, Sixty-one feet and eight inches to Main Street;

**THENCE** Easterly along the line of said Main Street, Twenty-seven feet to the place of beginning.

**BEING** the same lands as conveyed by Deed dated August 18, 1915 from Daniel M. Mattinson and Eleanor V. Mattinsom to Trustees of Laurie Lodge, Number 70, which was registered in Cumberland County Registry of Deeds at Amherst, Nova Scotia on September 2, 1915 in Book Number 125 at Pages 287 as Number 968-1915;

### LOT 2

**ALL** that certain lot of land situate in the Town of Springhill, in the County of Cumberland on the west side of Elm Street bounded and described as follows:

**BEGINNING** at the Southeast corner of lot already owned by said Trustees on the west side of Elm Street and as was conveyed to them on the 18<sup>th</sup> day of August, 1915, by Daniel M. Mattinson, to run southerly along said Elm Street, two feet;

THENCE Westerly parallel with said Trustees present south line twenty-seven feet;

**THENCE** Northerly parallel with first described line two feet to said Trustees presents Southwest Corner;

**THENCE** Easterly along said Trustees present south line, twenty-seven feet to the place of beginning.

**BEING** the same lands as conveyed by Warranty Deed dated March 10, 1930 from Daniel Murray and Jane B. Murray to Trustees Laurie Lodge No. 70 A.F. & A..M. which was registered in the Cumberland County Registry of Deeds on July 29, 1935 in Book 179 at Page 69 as No. 358-1935.
